

Isabella Township Regular Board Meeting

September 6, 2022

The Isabella Township Regular Board Meeting was called to order: by Supervisor Rick Ervin at 7:00 p.m. at the Isabella Township Hall.

Present were: Linda Bechtel, Rick Ervin, Hannah Fitzpatrick, Thomas Reihl, and Robert Walton

Meeting opened with Pledge of Allegiance led by Supervisor Rick Ervin.

Approval of Agenda: Rick Ervin moved to approve agenda. Robert Walton supported. Agenda approved.

Approval of Minutes: Minutes were reviewed from the August 8, 2022 meeting. Thomas Reihl made a motion, seconded by Robert Walton to approve the minutes as presented. Motion passed.

Public Comment: Mary Halfmann commented on Isabella Township Board doing a great job. Robert First commented about the election process and its complexities. Indicated a very rewarding and fun experience to take part in working. LouAnn Mogg commented on park restrooms. Marj Horan asked about website updates. - Tire recycle event will be held on October 1, 2022 from 8:00 am – 12:00 pm at the Isabella County Fairgrounds.
- Hazardous waste disposal will take place on October 22, 2022 from 8:00 am – 12:00 pm at the Isabella County Fairgrounds.

Financial Report: Linda Bechtel presented the Treasurers report. Thomas Reihl made a motion, seconded by Robert Walton to accept the financial report with an ending balance of \$855,220.41. A roll call vote was taken. All board members in attendance approved. Motion passed.

Hannah Fitzpatrick presented the bills. Rick Ervin made a motion, seconded by Thomas Reihl to pay checks #1127-1146. A roll call vote was taken. All board members in attendance approved to pay vouchers as presented. Motion passed.
