

Isabella Township Regular Board Meeting

The Isabella Township Regular Board Meeting was called to order: by Supervisor Rick Ervin at 7:00 p.m. at the Isabella Township Hall.

Present were: Linda Bechtel, Rick Ervin, Hannah Fitzpatrick, Thomas Reihl, and Robert Walton

Meeting opened with Pledge of Allegiance led by Supervisor Rick Ervin.

Approval of Agenda: Robert Walton moved to approve agenda. Thomas Reihl supported. Agenda approved.

Approval of Minutes: Minutes were reviewed from the March 7, 2022 meeting. Robert Walton made a motion, seconded by Thomas Reihl to approve the minutes as presented. Motion passed.

Guest Speaker: Jerry Neyer spoke about running for State Representative.

Public Comment: No members of the public offered comments.

New Business:

- A land split for Paul Faber was presented, parcel # 09-021-30-003-03. [Thomas Reihl made a resolution, seconded by Robert Walton to approve the land division as presented for parcel # 09-021-30-003-03. A roll call vote was taken. All board members in attendance approved.]
- Rick Ervin talked in detail about park damage from truck rally. Has been in contact with township attorney regarding matter.
- Rick Ervin spoke about creating park use contracts.
- 2% distribution funding and fire department radio project was submitted as partner project with Denver Township.
- No motorized vehicle signs were ordered for park.
- Rick Ervin announced that the May meeting would be moved to May 9, 2022 due to the May 3, 2022 election. Also moving the August meeting to August 8, 2022 and November meeting to November 1, 2022 due to elections.
- Electronic waste drop-off will be held May 14, 2022 at the Isabella County Fairgrounds from 8:00 a.m.-12:00 p.m.
- Tire recycling will be held on June 25, 2022 at the Isabella County Fairgrounds from 8:00 a.m.-12:00 p.m.
- 2022 brine contracts were discussed and cost will be around \$24,057 for two applications. [Thomas Reihl made a motion, seconded by Robert Walton to approve the brine contracts with the Isabella County Road Commission. A roll call vote was taken. All board members in attendance approved. Motion passed.]
- LouAnn Mogg presented ideas for park equipment update project and potential costs. [Robert Walton made a motion, seconded by Thomas Reihl to approve moving forward with park project, phase 1. A roll call vote was taken. All board members in attendance approved. Motion passed].
- Rubber Mulch for park project was discussed. [Thomas Reihl made a motion, seconded by Robert Walton to approve purchase of rubber mulch for park. A roll call vote was taken. All board members in attendance approved. Motion passed.]

Financial Report: Linda Bechtel presented the Treasurers report. Robert Walton made a motion, seconded by Thomas Reihl to accept the financial report with an ending balance of \$894,396.78. A roll call vote was taken. All board members in attendance approved. Motion passed.

Hannah Fitzpatrick presented the bills. Rick Ervin made a motion, seconded by Thomas Reihl to pay checks #12679-12703. A roll call vote was taken. All board members in attendance approved to pay vouchers as presented. Motion passed.
