July 6, 2026**

Board Meeting was called to order by Supervisor Rick Ervin at 7:00 p.m. at the Isabella Township Hall.

Meeting opened with Pledge of Allegiance led by Rick Ervin. Present: Linda Bechtel, Rick Ervin, Kristin Derby and Robert Walton. Absent: Thomas Reihl.

Approval of Agenda: Robert Walton moved to approve agenda. Linda Bechtel supported. Agenda approved.

Approval of Minutes: Minutes were read and reviewed from the June 1, 2026 regular business meeting. Robert Walton made a motion, seconded by Linda Bechtel, to approve the minutes as presented. Motion passed.
